A certificate of ARI-certified performance must be submitted. ALL homeowners must complete a rebate request form and provide proof of purchase to receive any 2009 Harrison REMC rebate. Deadline to apply for 2009 Rebate Program is Dec. 1, 2009. ALL homeowners and future homeowners receiving Harrison REMC rebates agree to the future installation of load control devices on these rebated appliances to allow Harrison REMC the opportunity to engage in future energy management load control procedures.
