**RATE:**

- Basic Service Charge: \$28.00 month
- On-Peak Energy Charge:  
\$0.25192/kWh
- Off-Peak Energy Charge:  
\$0.07333/kWh
- Super Off-Peak Energy Charge:  
\$0.05313/kWh

**POWER COST ADJUSTMENT:**

**OFF-PEAK MONTHS:**

Spring: *March, April, May*  
 Fall: *September, October, November*  
Super Off-Peak Hours:  
 11 pm-5 am daily

**WINTER MONTHS:**

*December, January, February*  
On-Peak Hours: Monday-Friday,  
 7 am-10 am, 6 pm to 9 pm EST  
Off-Peak Hours: 5 am-7 am, 10 am-6 pm,  
 9 pm-11 pm and weekends  
Super Off-Peak Hours: 11 pm-5 am daily

**SUMMER MONTHS:**

*June, July, August*  
On-Peak Hours:  
 Monday – Friday, 3 pm-9 pm EDT  
Off-Peak Hours:  
 5 am–3 pm and 9 pm-11 pm and weekends  
Super Off-Peak Hours: 11 pm-5 am daily

**TERMS/CONDITIONS:**

1. This request to implement time-of-use (TOU) pricing will become effective on the first day of the month following the receipt of this request, subject to the terms of any prior agreement.
2. The member agrees to switch to a calendar month billing cycle, processed on the 3rd of the month, due on the 22nd of each month.
3. Member may elect to opt out of this pricing option at any time during the 6-month period provided a written request is received prior to the 6-month anniversary date. If opt-out is selected, a billing adjustment will be made back to the standard rate for that period.
4. After the 6-month period, any future selection of a different pricing option will only be available upon any 12-month anniversary date from the implementation of this option, provided a written request is received prior to the effective date.
5. If terminated, this option will not be available for a minimum period of twelve months.
6. This pricing option is subject to all terms and conditions contained in the REMC's rate schedule TOU, which can be viewed at [harrisonremc.com](http://harrisonremc.com) or at the cooperative's office.

**AVAILABILITY:**

This rate is available to members in the territory served by the Corporation as an optional rate for Farm and Home use subject to the Corporation's Service Rules and Regulations.

**TYPE OF SERVICE:**

Single phase, 60 hertz at a standard voltage (120/240) delivered through a single meter point to accounts with installed transformer capacity of less than 50 kVA.
