- Must be installed in a home served by Harrison REMC.
- Heat pumps are for whole-home installations only with exception of the Single-Room Mini-Split Heat Pump.
- SEER2 ratings must be obtained from the AHRI certificate.
- An AHRI Certificate must accompany the application and invoice to be qualified. You can obtain the AHRI certificate from your contractor or from the manufacturer.
- Limit of two (2) rebates allowed per member account per useful life of rebated equipment.
- Submission for rebates must be within 90 days of installation and by December 15, 2024.
- Incentive amount can not exceed 50% of equipment cost.
